1	Transfer currency should be same as the account currency of the client. Currency of transfers is Ukrainian hryvnia, except payments within one client's current accounts/payment cards opened and/or issued in PJSC "Ukrasotsbank".		
2	Commission for payments from card accounts/payment cards is charged from account/card currency. Commission for payments from current accounts in foreign currency is charged in UAH from client's current account in UAH. Commission for payments from current accounts in UAH is charged in UAH from client's current account in UAH.		
3	Funds transfer to deposit accounts in the form of refilling is carried out in the case when such an operation is provided by the terms of the deposit. Service of funds transfer from the current, card account/payment card to a non-resident deposit account of another non-resident is not available. Funds transfer of own transit account (3739) for the loan repayment is not charged. Transfers between own cards in foreign currency are not supported.		
4	Only transfers from/to own current account and on own Saving + deposit account are available with Saving deposit account.		
5	Funds transfer is allowed between cards of residents. Max transfer amount - 14 999 UAH per transaction, 75 000 UAH per day, 150 000 UAH per month for each card.
